SUMMARY

OFFER PRICE

- The Offer Price has been determined at HK\$14.26 per Offer Share (exclusive of brokerage of 1.0%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).

NET PROCEEDS FROM THE GLOBAL OFFERING

- Based on the Offer Price of HK\$14.26 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting fees and commissions and other estimated expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$7,640 million based on the latest estimation (assuming the Over-allotment Option is not exercised). The Company intends to apply such net proceeds in accordance with the purposes as set out in the section headed “Net Proceeds from the Global Offering” in this announcement.

APPLICATIONS AND INDICATIONS OF INTEREST RECEIVED

Hong Kong Public Offering

- The Hong Kong Offer Shares initially offered under the Hong Kong Public Offering have been moderately over-subscribed. A total of 11,277 valid applications have been received pursuant to the Hong Kong Public Offering on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS and under the **HK eIPO White Form** service (www.hkeipo.hk) for a total of 454,182,000 Hong Kong Offer Shares, representing approximately 11.77 times of the total number of 38,590,000 Hong Kong Offer Shares initially available for subscription under the Hong Kong Public Offering.
- As the Offer Shares initially offered under the Hong Kong Public Offering have been moderately over-subscribed, no clawback mechanism was effected. 38,590,000 Offer Shares will be allotted and issued to the applicants under the Hong Kong Public Offering, representing approximately 7% of the total number of the Offer Shares initially available under the Global Offering (assuming the Over-allotment Option is not exercised).

INTERNATIONAL OFFERING

- The Offer Shares initially offered under the International Offering have been significantly over-subscribed. The final number of Offer Shares allocated to the places under the International Offering is 512,690,000 Offer Shares, representing approximately 93% of the total number of Offer Shares initially available under the Global Offering (assuming the Over-allotment Option is not exercised). There has been an over-allocation of 82,692,000 Shares in the International Offering and such over-allocation will be settled using Shares to be borrowed under the Stock Borrowing Agreement between APEX MEDICAL COMPANY LTD. and Morgan Stanley & Co. International plc. Such borrowed Shares will be covered by exercising the Over-allotment Option or by making purchases in the secondary market or by a combination of these means.

Over-allotment Option

- In connection with the Global Offering, the Company has granted the Over-allotment Option to the International Underwriters, exercisable by the Joint Global Coordinators (on behalf of the International Underwriters) from the date of the International Underwriting Agreement up to (and including) the date which is the thirtieth day from the last day for lodging applications under the Hong Kong Public Offering to require the Company to allot and issue up to an aggregate of 82,692,000 additional Shares, representing 15% of the Shares initially being offered under the Global Offering, at the Offer Price. There has been an over-allocation of 82,692,000 Shares in the International Offering and such over-allocation will be settled using Shares to be borrowed under the Stock Borrowing Agreement between APEX MEDICAL COMPANY LTD. and Morgan Stanley & Co. International plc. Such Borrowed Shares will be covered by exercising the Over-allotment Option or by making purchases in the secondary market or a combination of these means. In the event that the Over-allotment Option is exercised, an announcement will be made on the Stock Exchange's website at www.hkexnews.hk and the Company's website at www.hspharm.com. As of the date of this announcement, the Over-allotment Option has not been exercised.

Cornerstone Investors

- Pursuant to the Cornerstone Investment Agreements with the Cornerstone Investors, the number of Offer Shares subscribed for by the Cornerstone Investors has been determined. GIC Private Limited subscribed for 38,532,000 Shares, Boyu Capital Opportunities Master Fund subscribed for 33,026,000 Shares, Ally Bridge LB Healthcare Master Fund Limited subscribed for

22,018,000 Shares, OrbiMed subscribed for 22,018,000 Shares, Prime Capital Funds subscribed for 22,018,000 Shares, Hillhouse Funds subscribed for 16,042,000 Shares, Cormorant Asset Management, LP subscribed for 13,760,000 Shares, Shanghai Pharmaceuticals (HK) Investment Limited subscribed for 11,008,000 Shares, and Vivo Funds subscribed for 11,008,000 Shares, in all totalling 189,430,000 Shares representing in aggregate (i) approximately 3.32% of the Company's total issued share capital following the completion of the Global Offering; and (ii) approximately 34.36% of the number of Offer Shares under the Global Offering, assuming the Over-allotment Option is not exercised. - To the best knowledge of the Company, except for Boyu Capital Opportunities Master Fund and Hillhouse Funds, each of the Cornerstone Investors is an Independent Third Party, and none of the Cornerstone Investors is a core connected person of the Company, an existing shareholder of the Company or its close associate. The Offer Shares to be subscribed by the Cornerstone Investors will rank *pari passu* in all respects with the fully paid Shares in issue. Save as disclosed in the Prospectus, immediately following the completion of the Global Offering, none of the Cornerstone Investors will have any Board representation in the Company, nor will any of the Cornerstone Investors become a substantial shareholder (as defined under the Listing Rules) of the Company. The Cornerstone Investors do not have any preferential rights in the Cornerstone Investment Agreements compared with other public Shareholders other than the preferential treatment of assured entitlement under a cornerstone investment following the principles set out in HKEx-GL51-13.

The Company has applied to the Hong Kong Stock Exchange for, and the Hong Kong Stock Exchange has granted the Company, consent under the Placing Guidelines to permit the Company to allocate Offer Shares in the International Offering to Morgan Stanley Investment Management Company, UBS Asset Management (Singapore) Ltd. and UBS Asset Management (Hong Kong) Limited.
- Under the Global Offering, (i) 1,650,000 Shares were allocated to Morgan Stanley Investment Management Company, which is connected with Morgan Stanley Asia Limited and Morgan Stanley & Co. Based on the Offer Price of HK\$14.26 per Offer Share, the net proceeds from the Global Offering to be received by the Company, after deduction of the underwriting fees and commissions and other estimated expenses payable by the Company in connection with the Global Offering, are estimated to be approximately HK\$7,640 million based on the latest estimation (assuming the Over-Allotment Option is not exercised). The Company intends to apply such net proceeds for the following purposes:

- approximately 45%, or HK\$3,438 million, on R&D, including on the Company's existing and future domestic and overseas drug development programs, expanding its R&D team, and investment in technologies to further enhance its R&D capabilities and enrich its product pipeline. Specifically, approximately 50%, or HK\$1,719 million, on the research and development of innovative drugs.
